Engagements with Kuwaiti Consul General

The Arabia CSR Network instituted the Arabia CSR Awards in 2008 with a vision to honour the organisations in the Arab World for their outstanding leadership in Corporate Social Responsibility and Sustainability. The awards are acclaimed as the 'Green Oscars of Middle East', and continue to prove itself as a home-grown product of the MENA Region that promotes and elevates organisations that have successfully molded CSR and sustainability best practices in their core businesses and operations.

Building on the growing importance of CSR globally, Arabia CSR Network, Founder, President and CEO, Ms. Habiba Al Mar'ashi met with H.E. Ali Salem Al-Zaidi, Consul General of Kuwait, Dubai on **10th Jan 2023**. They discussed the background history of Arabia CSR Awards and its momentous growth in the Arab Region. The meetings facilitated a discussion to advance and scale up the reach of the Awards in the GCC and contribute to the Sustainable Development of the region. The Network is seeking out "influencers" and strong "green" voices within the sustainability domain to foster growth and recognise the CSR champions of the region.

National Dialogue on Climate Ambition (NDCA)

Climate change is one of the most important environmental issues at the national and global levels, given its economic, social and environmental impacts. This issue has received considerable and early attention in the UAE and the country has exerted numerous efforts to address the effects of climate change. The Ministry of Climate Change and Environment (Moccae) launched the National Dialogue for Climate Ambition (NDCA) in 2022 to step up climate and advance all-inclusive stakeholder participation in the UAE Net Zero by 2050 Strategic Initiative.

On **16th January 2023**, MoCCAE held the 8th session of the NDCA under the theme "Adaptation in the Context of Community behaviour". The event was conducted during the Abu Dhabi Sustainable Week that Mrs. Al Mar'ashi, attended physically.

H.E Mariam bint Mohammed Almheiri, Minister of Climate Change and Environment, graced the event and opened the assembly with a keynote speech on the topic. This was followed by a dialogue of the Interactive Youth Circle that aimed to highlight integration and prioritisation of Children, NGO's, Civil Societies, Youth and People of Determination in Climate action, climate anxiety and the role of education in managing that.

Launch of 16th cycle of Arabia CSR Awards 2023

The Arabia CSR Awards was instituted in 2008 with a vision to honour the organisations' in the Arab World for their outstanding leadership in Corporate Social Responsibility and Sustainability arena. The Awards since its inception has become the 'sustainability benchmark of the Arab Region'. Each successive cycle has solidified the awards' reputation as the mirror through which entities are able to gauge their performance with their peers and competitors.

Currently in its 16th cycle - the Arabia CSR Awards were launched in a press conference held at Five Palm Jumeirah on **23rd January 2023**. The event was held in a hybrid manner to give convenience to regional applicants & provide participants with a complete overview of the registration, applications & submission procedures, best practices on CSR & Sustainability from previous winners.

The conference began with a presentation by Mrs. Habiba Al Mar'ashi wherein she took the audience briefly over the Awards history and its journey since its inception in 2008. Following her presentation, representatives of the winners of the Arabia CSR Awards 2022 then relayed their experiences and explained how their organisations managed to







claim winning positions. They further explained the overall benefits that participating in the Awards has had on their sustainability performance and strongly encouraged all those present to embark on the journey of the Awards and inspire others in their circles to do the same.

The Awards Secretariat then ran with the audience the newly launched awards website. The guidelines of the Awards, registration procedure, application tips, and timeframe were all shared with the audience. Lastly, there was a Q&A session where the audience pondered on the challenges and the experts cleared their doubts.

ACSRN President concluded the session by expressing her appreciation to all the panelists for coming forward and sharing their views. She urged the participants to grab the opportunity to compete & showcase their achievements in a bid to honour their efforts and inspire others to follow suit. While closing the ceremony, she wished good luck to the aspiring applicants and conveyed her excitement at the start of yet another great Cycle.

Can the GCC manage the region's food crisis?

The GCC since decades have been affected by scarce water availability.

However, recently this system has begun to show its limitations. In the wake of the COVID-19 pandemic, as supply chains slowed and countries struggled to adapt to a new normal, the financial ability to procure goods was no longer a guarantee of success. The turmoil that ensued led to concerns for the future of food security in the region. It was the latest in a series of wake-up calls for local governments, highlighting the need to strengthen local food systems. In the past few months, food technology investments in the region have intensified. New initiatives and partnerships have made the news,



revealing GCC countries' commitment to a new way forward.

Let's take a closer look at a couple of GCC countries who have launched notable initiatives to boost food security:

UAE: The UAE Ministry of Health and Prevention (MoHAP) launched the UAE National Nutrition Strategy 2022-2030, which lays out a comprehensive roadmap for developing sustainable healthy food systems, establishing supportive healthy food environments, and promoting healthy food choices in the UAE. In 2021, the country unveiled the first of a series of projects aimed at tripling its food production, a major innovation district combining laboratories, research centers, and prototype agricultural systems. Lastly, in November, government agency Tamkeen and the UAE Ministry of Climate Change and Environment launched the FoodTech Challenge, a \$2 million competition seeking to identify technology innovations capable of efficiently and sustainably transforming traditional agricultural practices.

Qatar: Another contender for the top innovation hotspots in the Gulf region is Qatar. It is following a similar path to food independence as that of UAE. The Qatari government launched the Qatar National Food Security Strategy 2018–2023 to deliver high-quality food at reasonable rates through domestic production, strategic storage, and reliable import sources. Early in 2022, Qatar's sovereign wealth fund led a \$250M investment round in French vertical insect farm operator.

Best Practices 2021 From The Archives Zurich International Life Arabia CSR Awards 1st Runner Up - Financial Services Category

Profile

Zurich International Life has been present in the Middle East region for 32 years, providing a range of protection and savings solutions designed to meet changing customer needs and market conditions. Part of Zurich Insurance Group is its Middle East presence which covers the United Arab Emirates, Qatar and Bahrain, with a 23% market share and close to 300,000 customers across both retail and corporate segments. The Zurich Insurance Group is a multi-line insurer that serves its customers in global and local markets. With about 55,000 employees, it provides a wide range of property and casualty, life insurance products and services in more than 215 countries and territories. Zurich's customers include individuals, small businesses, medium-sized and large companies, as well as multinational corporations.





Zurich International Life has put a lot of emphasis on environmental issues at the local level, as well as on issues of social importance. Several measures have been taken to decrease carbon emissions from company-operations, thereby taking positive steps to reduce climate change impact, energy consumption and conservation of natural resources. It has established the Zurich Foundation, and its key pillars are adapting to climate change, improving mental wellbeing and enabling social equity. It has showcased a model which others can replicate since it has continued to have a robust mechanism to ensure focus remains on its people throughout the pandemic, with zero lay-offs or salary reductions, offering employees new flexible ways of working to allow for a sustainable work-life balance.

Lessons Learnt

Zurich International Life has taken social responsibility very seriously in the Middle East. Various regional initiatives which it has undertaken are commendable. These include its digital solutions offer, like the two direct-to-customer products -which removes the requirement for paperwork and boosts customers' experience.

The company's work with the community has included its efforts through Zurich Cares. Additionally, it has supported two special needs centres in the UAE. In 2020-2021, it supported the building of two additional classrooms in Al Noor Centre for Children with Special Needs. To provide personal and professional support to its employees, Zurich has formed Employee Resource Groups that run several initiatives in ME including Zurich Ethics hotline, Dignity@Work policy and Employee Assistance Programme.

Zurich International Life has focused on recycling and energy efficiency. Wherever possible, the company has implemented paperless practices since April 2020; It has separated various kinds of waste by placing segregated waster bins throughout its office locations. Different initiatives at its premises have helped conserve power and consumption of water. In 2021, the company recycled 2,550 kg of paper under the "For Our Emirates We Plant" initiative, receiving Emirates Environmental Group's certificate of appreciation.

During the COVID-19 pandemic phase, the Zurich Foundation supported UNICEF's global efforts to help deliver COVID-19 vaccines to the world's most vulnerable, with an initial donation of CHF 1 million. The programme was also supported by various local fundraising activities with a total donation of up to CHF 2.5 million.
