#### **World's Most Remote Robot Automates Amazon Reforestation Project**

A pilot project between ABB Robotics and non-profit organisation Jungle-keepers is demonstrating the role Cloud technology can play in making reforestation faster, more efficient and scalable.

ABB Robotics is supporting Jungle-keepers in their mission to protect 55,000 acres of the Amazon rainforest. In a first-of-its-kind demonstration, ABB's cobot (collaborative robot) "YuMi" is automating planting tasks in a jungle laboratory. Through cloud technology, ABB experts simulate, refine and deploy the programming required for YuMi's tasks in the jungle from 12,000 km away in Sweden – enabling the world's most remote robot.

The cobot has been installed to automate essential tasks in the seed planting process, usually an entirely manual effort. It digs a hole in the soil, drops the seed in, compacts the soil on top and marks it with a colour-coded tag. YuMi enables Jungle-keepers to replant an area the size of two soccer fields every day. By automating this task, Jungle-keepers' volunteers are able to focus their valuable time and resources on patrolling the area to deter illegal loggers, educating locals on the preservation of the rainforest and planting mature saplings.

- 1. Diversification of Water Sources
- 2. Demand Management and Conservation
- 3. Green Infrastructure and Sustainable Drainage Systems
- 4. Water Sensitive Urban Design (WSUD)
- 5. Integrated Water Management
- 6. Climate Resilience and Adaptation
- 7. Collaboration and Governance
- 8. Continuous Monitoring and Evaluation

# Best Practices 2021 From The Archives Ministry of Economy

1st Runner Up - Public Sector Category - Medium

#### **Profile**

The Ministry of Economy of the United Arab Emirates was established in 1971 when the federation was formed. This government agency is a medium sized organisation with a mission to achieve national economic development and competitiveness; create an environment that encourages business growth by enacting and modernising legislations and foreign trade policies, expanding and promoting national exports, developing the country's tourism sector by improving its products and enhancing its quality, encouraging investment, regulating competition and SMEs sector, protecting consumer rights and intellectual properties, supporting the efforts of cooperative associations, diversifying economic activities and adopting smart apps.



As a country with a long-standing legacy of humanitarian work, charitable contributions and with a strong record of philanthropic work in many parts of the world, it was a natural progression that Corporate Social Responsibility (CSR) would be a focus area and a strategy for creating a regulatory framework for the same would be developed by the Ministry as the leading agency of the government. The National Fund for Corporate Social Responsibility was established through Cabinet Resolution No. 2 of 2018. The following year, a Smart Platform for Corporate Social Responsibility was launched in the presence of HH Sheikh Mohammed bin Rashid Al Maktoum, Vice President and Prime Minister of the UAE and Ruler of Dubai. The platform aims to engage all state owned commercial enterprises to practice CSR as a traditional mandate, as well as private sector companies, thus creating a unique and effective public private partnership.

Within the scope of the Fund, a National Index of Corporate Social Responsibility was developed with the aim of assessing CSR practices in the United Arab Emirates in relation to established international standards. The National CSR Fund Smart Platform and National CSR Index are the twin components of a first of its kind initiative to harness public and private CSR contributions on to a common platform and formally acknowledge the impacts of the same via a rating mechanism following international standards and benchmarks. The challenges faced were addressed by launching the CSR Index and the CSR Passport, both of which aim to motivate and inspire the uptake of CSR and sustainability amongst entities in the UAE. Additionally, by providing wide scale coverage and benefits thereof on the brand and building the reputation of these entities has gone a long way in putting CSR on the high level agenda of public and private sector establishments. Finally, the Fund encapsulates the deep commitment of the UAE to align with global sustainable development goals and create real impact on the ground locally.

#### **Conclusion & Lessons Learnt**

Before and during the development of the CSR initiative, the Ministry faced several challenges, the most prominent being the following:

- Low level of CSR awareness among a large number of companies, necessitating the need for effective incentives to encourage companies to participate.
- Company initiatives were mostly undeveloped or unregulated; therefore initiatives with a clear organisational framework and more strategic and impactful were required to be developed.
- Absence of any proper guidance regarding the sectors relying on social intervention by institutions, with initiatives being limited to CSR projects in specific areas (education, health, environment), which may not create tangible results for these sectors or the beneficiaries.
- Lack of incentives from the state to encourage the development of corporate social responsibility, such as reduced taxation or loans with reduced interest rates for socially responsible organisations, and the kind.
